**PROCUREMENT OF TABLETS UNDER THE HEADS
OF AGREEMENT BETWEEN THE JAMAICA
TEACHERS' ASSOCIATION (JTA) AND THE
GOVERNMENT OF JAMAICA (GOJ)
TABLETS FOR TEACHERS PROGRAMME (TTP)**

e-Learning Jamaica Co. Ltd. will be procuring 25,000 tablets over the next fifteen months for the Tablets for Teachers Programme (TTP) being executed during the 2017-2021 contract period, based on an agreement between the Jamaica Teachers' Association and the Government of Jamaica. Under this Agreement, tablets will be provided for all public sector teachers island-wide, with the value of each tablet being approximately US\$200. The 25,000 tablets are to be supplied in two (2) tranches comprising 15,000 in Tranche 1 and 10,000 in Tranche 2.

ELIGIBILITY REQUIREMENTS

To be considered eligible at the time of tender opening, your tender must include the following:

- Copy of a valid Tax Com Compliance Certificate (TCC) / Tax Compliance Letter (TCL) (In the case of foreign Bidders, where the bid is successful, the foreign bidder shall be required to provide a valid TCC / TCL at the time of the award of contract.)
- Proof of current registration with the Public Procurement Commission (PPC) / NCC in the category of Computers and Related Services OR Computers and Supplies (In the case of foreign Bidders, where the bid is successful, the foreign bidder shall be required to demonstrate proof of PPC registration at the time of the award of contract.)
- Proof of local office or local authorized dealer
- Completed and signed Manufacturer's Authorization Form/ Reseller Agreement from VAR
- Completed and signed Bid Submission Form
- Power of Attorney authorizing the signatory of the bid to commit the bidder
- Statement of Price Compliance
- Completed and signed Bid Submission Form
- Bid Security

Non-compliance with all or any of the criteria above will result in automatic disqualification of tender.

SCOPE OF WORK

Supply of tablets, post-implementation support and warranty repairs.

AVAILABILITY OF DOCUMENTS

Bidding documents will be available for download as at **October 1, 2019** on the Government of Jamaica Electronic Procurement website - **www.gojep.gov.jm**.

RETURN OF TENDERS

Bids must be submitted online via **www.gojep.gov.jm** no later than **October 31, 2019 at 3:00 p.m.** An online bid opening will take place on the same date at **3:15 p.m.** An online bid opening report will be sent to all bidders who submit a bid.

This is an online Tender where tender documents and supplier bids will only be made available and accepted via the electronic Government Procurement Portal (**www.gojep.gov.jm**). No offline (hard copies) of bids will be accepted and there will be no physical tender box for drop-off of tender documents.

To participate in this tender opportunity, suppliers must first be registered on the Government of Jamaica Electronic Procurement System. To register, select the **'Register as a supplier'** link from the system home page.
